

Terms & Conditions

In consideration of and as a condition of acceptance of entry in the 2022 CJD Run or Ride for Ronnie 6km *Event*, 3km *Event* or Motorbike Ride *Event* (collectively, the “Event”) on Saturday 12 November 2022 (the “Event Date”). *You* acknowledge and agree with the following (“*You*, *Your* or *Yourself*” meaning the applicant or participant):

Under 18 entries

1. If *You* are under 18 years of age on the date of the *Event*, a parent or guardian must accept the Terms & Conditions. Where no consent is provided, *You* warrant that *You* are 18 years of age or older on the *Event Date*.

General Participation

2. At the *Event*, *You* agree to comply with all the rules and directions of officials. When participating in the *Event*, *You* also agree to follow the approved course, observe normal traffic rules and obey all directions and instructions given by officials and/or police.
3. *You* agree that *You* may not participate in the *Event* or arrange for support personnel with or using roller skates, roller blades, skateboards, bicycles, scooters, dogs/animals or any non-traditional form of running shoe.
4. The course crosses numerous roads throughout the route. *You* understand that care should always be taken when crossing roads & *You* must follow the instructions of the traffic marshals when crossing.
5. *You* must hold a valid Victorian Motorcycle Licence for the Motorbike Ride *Event*. All riders must follow all Victorian permit restrictions, including and not limited to, Leaner riders having your headlight(s) on, displaying an ‘L’ plate on the rear, and wearing a High Visibility vest or jacket at all times.

Charity

6. CJD Run or Ride for Ronnie is hosted by the CJD Support Group Network Ltd. All entry fees will be directed towards the management and implementation of the *Event*. All profit from this *Event* will go directly to CJD Support Group Network Ltd.

Course

7. *You* understand that CJD Run or Ride for Ronnie committee reserves the right to alter the course and/or *Event* format at any time prior to the start of the *Event*, this includes changing the distance of the course due to any unforeseen circumstances. Such alterations may be due to the direction of councils, police, roadworks or other organisations that are associated with the *Event*.

Participants

8. *You* must be medically and physically fit and able to participate in the *Event*.
 - i) If *You* are unsure about your medical and physical fitness *You* must seek advice from a medical practitioner before attending the *Event*.
9. *You* must not be a danger to *Yourself* or to the health and safety of other participants.

10. CJD Run or Ride for Ronnie committee reserves the right to refuse any application for entry into the *Event* for any reason
11. *You* must immediately notify CJD Run or Ride for Ronnie committee in writing of any change to *Your* fitness and ability to participate in the *Event*. Where *You* do not provide any written notice to CJD Run or Ride for Ronnie committee, CJD Run or Ride for Ronnie committee will rely upon this as evidence of *Your* fitness and ability to participate in the *Event*.
12. In applying to participate in this *Event*, *You* consent to receiving any medical treatment that the *Event* organisers or their authorised representatives (including emergency services providers) consider reasonably necessary or desirable during or shortly after the *Event*. *You* must reimburse the *Event* organiser and/or their authorised representative for any costs or expenses incurred in association with providing *You* with medical treatment.
13. *You* acknowledge that participation in the *Event* can be inherently dangerous and that *You* may be exposed to certain risks during the *Event* including, but not limited to, overexertion, equipment failure, dehydration, serious accidents, and risks associated with the course and adverse weather conditions. These risks can and often eventuate and they may result in *You* being personally injured or killed or *Your* property being damaged or the *Event* being cancelled. By entering into or participating in the *Event*, *You* agree that:
 - a. *You* have read and understood the risks associated with participating in the *Event* and this warning, and accept and assume the inherent risks in participating in the *Event*.
 - b. *You* acknowledge and agree that the insurance policy which is in place for the *Event* may only provide limited cover to *You* whilst participating in the *Event*. *You* understand that this insurance may not cover *You* for injury, loss or damage sustained by *You* in participating in the *Event* and *You* acknowledge that CJD Run or Ride for Ronnie committee does not make any representations about the suitability of the insurance. *You* also agree that *You* can, in *Your* own interests and at *Your* own expense, seek and obtain personal insurance for the *Event*.
 - c. *You* are fully responsible for the security of *Your* personal possessions at the *Event* including other valuable items. *You* agree that CJD Run or Ride for Ronnie committee is not responsible or liable for the repair or replacement of any personal possessions whether lost, damaged, stolen or otherwise.
14. In connection with the *Event*, *You* agree not to mislead *Event* officials, obtain an advantage by deception or otherwise act dishonestly.

Cancellations / Transfers

15. *You* acknowledge and agree that due to the nature of this *Event* and the element of chance in the prevailing conditions, that *Your* entry and participation in the *Event* may be affected by matters outside of the control of officials, including but not limited to the weather, safety and associated conditions. *You* accept that in such circumstances officials have the right to alter the format of, shorten, or cancel the *Event* in the interest of competitor safety. Officials will use all reasonable efforts to conduct the *Event* in the planned format if safe to do so. Should any reason outside the control of officials, including without limitation weather or other dangerous conditions, war, strike or any other act of god force any change,

- You* accept that CJD Run or Ride for Ronnie committee is not obliged to provide *You* with any refund, credit, transfer to another CJD Run or Ride for Ronnie *Event* or to restage the *Event*.
16. Entries are non-transferable to other *Events*. If you wish to switch into a different distance for the *Event*, you may do so free of charge before 4pm 14 days before the *Event Date*. No transfers will be granted within 14 days of the *Event Date*.
 17. Any attempt to transfer *Your* entry to another person without the knowledge of CJD Run or Ride for Ronnie committee may result in the cancellation of *Your* entry without refund and *You* may be prohibited from participating in other CJD Run or Ride committee *Events*.
 18. *You* must not offer *Your* (or any other persons) entry for sale through any medium, including auctions (on eBay or any other auctioning or similar means). All individuals involved in such conduct will be disqualified from the *Event*.
 19. *You* acknowledge that the entry fee is not refundable. *You* understand that if *You* do not wish to participate in the *Event*, *You* must notify CJD Run or Ride for Ronnie committee.

Personal Details

20. *You* acknowledge that the information that *You* provide with this application is necessary to the conduct the *Event*. *You* acknowledge and agree that the information provided will be used by CJD Run or Ride for Ronnie committee to facilitate the administration of the *Event* and for future marketing and promotional purposes relating to CJD Run or Ride for Ronnie committee *Events*. CJD Run or Ride for Ronnie committee may disclose your personal information to third parties involved in the *Event*, including but not limited to the Warrnambool City Council.
21. *You* understand that *You* will be able to access *Your* information through CJD Run or Ride for Ronnie committee via email runorrideforronnie@gmail.com
22. *You* warrant that the information *You* provide in *Your* application is correct. If *You* provide incorrect information, officials may disqualify *You* from the *Event* and *You* may be ineligible to participate in future CJD Run or Ride for Ronnie *Events*.
23. *You* consent to the organisers using *Your* name, image, likeness, voice, statement and also *Your* performance in the *Event* (including the publication of *Your* name and/or *Event* result, suburb and applicable age bracket), at any time, to promote the *Event* or any future similar *Events* by any form of media.
24. *You* consent to receiving electronic emails from the *Event* organisers or their authorised representatives prior to and after the *Event*. Unless *You* have nominated otherwise, *You* acknowledge and agree that *Your* information may also be used for marketing purposes by a third party or *Event* sponsor.
25. *You* grant CJD Run or Ride for Ronnie committee, the contractors and suppliers engaged by CJD Run or Ride for Ronnie committee in connection with the *Event* a royalty free right for use in perpetuity, to use and allow the use of my name, image, voice, likeness, photograph, interview and statement in broadcasts, telecasts, webcasts, media press materials, promotional materials and otherwise in connection with the *Event*. *You* acknowledge that the official *Event* results list, published publically, will display my name, corresponding Event number and finish time.
